Discounted Pricing Proposal

Description

As part of a preferred vendor agreement arrangement OurRecords will provide discounted pricing available to Fidelity National Financial and FNF's nationwide settlement agents. We would like to make this pricing offer available to **FNF for 30 days**, and if accepted guarantee the discounted pricing for **24 month term**.

Pricing Proposal

OurRecords pricing has 3 primary components: software licensing for vetting companies, software licensing for vetted company sponsorships and Secure Intelligent File Transfer (SIFT) subscription pricing.

Vetting Company / Organization Annual Licensing

Pursuant to OurRecords and Fidelity National Financial preferred vendor agreement OurRecords will offer discounted pricing to organizations that wish to use OurRecords to credential or vet their vendor or employee populations. (Examples may include but will not be limited to notaries, appraisers, surveyors, signing services, escrow officers, and employees.) Each of these licenses allows you to monitor set requirements for individual members and/or organization vendor populations for compliance with your specific requirements.

Vetting Company Account Annual Sponsorships

Pursuant to OurRecords and Fidelity National Financial preferred vendor agreement OurRecords will offer discounted pricing to organizations that wish to use OurRecords to credential or vet their vendor or employee populations, and sponsor some percentage of those accounts (i.e. be financially responsible for their account membership fees). Examples may include but will not be limited to wanting to pay for employee accounts, or settlement agent basic membership accounts to submit documentation back to requesting organization.

Secure Intelligent File Transfer (SIFT) Monthly Licensing
